

These actions enable PSS functionality for the data source that contains user authentication information and define the logic for PSS requests using BRFplus application. Therefore, A and C are the correct answers. B and D are not valid actions for configuring PSS, as they are related to other aspects of connector configuration, such as connector settings and connector groups. Reference: 2
